HOW IT WORKS

As a topical spray SNS 244™ Fungicide kills the fungus through a biochemical interaction on the spores. Some of the components of SNS 244™ Fungicide are also absorbed systemically by the plant, suppressing the life cycle of the fungal spores and nurturing the plant cells to increase the plant's ability to fight and prevent the disease.

DIRECTIONS

SHAKE WELL BEFORE USE

Foliar Spray - Plant Site Use For All Plants
(Leaves "Foliage," Stems, Stalk, Fruit and around Flowers), **Coverage** = 1 gallon solution will cover approximately 550 square feet. No restricted entry interval (REI)=0 days.

Water infected plants well before spraying SNS 244™. Spray at night or when the lights are off and the plants are completely cooled down. Spray directly onto infected areas until thoroughly covered.

Depending upon severity of infestation several applications may be required. For heavy infestations spray every other day until you have control of the problem. Use on a 7-14 day schedule as preventative maintenance.
